## The Operational Guide

The Guide is a practical tool designed to strengthen the capacity of NHRIs to engage in torture prevention in their countries. The first part provides the legal context for torture prevention. The second part outlines the practical steps that NHRIs can undertake to prevent torture, illustrated with examples of good practices.

It is available in English, Spanish, French, Serbian and Arabic.

## The CD Rom

The Guide is complemented by a CD Rom (also available online) that contains an electronic version of the guide, as well as relevant documents and further readings. It also features <u>audio-visual support</u> in the form of a documentary featuring interviews with leading international experts, as well as interviews with representatives of NHRIs in Asia-Pacific describing their work on different aspects of torture prevention.

#### OHCHR Practical Guide on Preventing Torture: The Role of National Preventive Mechanisms

This Guide draws on the decade-long expertise of the Subcommittee on Prevention of Torture in guiding and advising on NPMs. It summarizes the Subcommittee's documents and recommendations in a simple, practical guide to assist States – both States parties to the Optional Protocol, and those considering becoming a State party – to establish or strengthen their NPMs. It also builds on the experience of OHCHR staff in the field, many of whom have been and continue to be instrumental in supporting NPMs with human rights expertise on the ground.
